Florida Requirement Details for Real Estate Continuing Education. Continuing Education and License Renewal Date: 3/31 or 9/30 every two years. The date you renew depends on when you initially took your licensing exam. Hours Required By The State: 14 hours. Due to new Florida requirements, you may require different hours based on your renewal date.

Florida Real Estate Continuing Education Requirements: Florida Real Estate Sales Associates and Brokers must complete 14 hours of state approved continuing education (including 3 hours of Core Law) every 2 years by either March 31 st or September 30 th, based on their license expiration date.

Florida Real Estate Continuing Education and License Renewal

Continuing Education. After completing the 45 hours (for Sales Associates) or 60 hours (for Brokers) of post-license education, you are required to complete 14 hours of Florida real estate continuing education during every two-year license period thereafter.

Florida Real Estate Continuing Education Course. In the state of Florida, real estate sales associates and brokers are required to complete 14-hours of approved continuing education every two years, before their license expiration date. This date can be found printed on your license, or by visiting the DBPR at www.myfloridalicense.com.

Continuing Education Courses. In the 2nd and subsequent renewal periods which are 24 months in duration, real estate licensees are required to complete 14-hours of approved continuing education courses (11 hours of specialty continuing education and 3 hours of Florida law update) and end of course exam (distance education courses only).

CE (Continuing Education) - IFREC Real Estate Schools

You may take the sales associate's examination by affixing a copy of your current Bar card to the examination application. Any active member in good standing with The Florida Bar and who is otherwise qualified under the real estate license law is exempt from the continuing education requirements for real estate licensees.

Real Estate Licensees are required to complete 14-hours of approved Continuing Education courses and end of course exams (distance Education Courses only). Unlike the Pre and Post Licensure course content, the Continuing Education requirements for Sales Associates, Brokers and Broker Associates are identical.

Real Estate Education Requirements - Florida Department of ...

Real estate license renewal information. To maintain your real estate license, all licensees must comply with post-licensing or continuing education requirements and pay the necessary renewal fees. This also applies to those licensees with a suspended license.
